- Discuss petroleum program topics of regional interest




WSPC Steady-State Meeting Hosts



PLANNING OPPORTUNITIES

- WSPC invited to participate in Oregon's ESP development
 - Stakeholder Engagement Kickoff Meeting – Data collection to inform risk assessment (10-16-23)
 - Series of hybrid and virtual meetings – rank energy sector threats and prioritize mitigation measures (Spring 2024)
- Oregon and California participated in Nevada's ESP Revision Stakeholder Meeting (06-15-23)

Opportunities for Regional Collaboration





MULTI-STATE EXERCISE OPPORTUNITIES

- WSPC participated in 2021 USDOE Clear Path IX Fuels Tabletop to improve understanding of federal resources and capabilities available to support fuel operations in multi-state events
- IronOR 24 ESF 12 to demonstrate fuel logistics and supply chain management, fuel allocation prioritization, and WSPC regional coordination (Oct 28 - Nov 1, 2024)
- Oregon Fuel & Rail Tabletop Planning Underway Lessons learned from September 2023 Idaho private sector exercise generated interest for tabletop - opportunity WSPC collaboration

Opportunities for Regional Collaboration





Response Opportunities

- 2021 Wildfires Oregon activated multistate coordinated response for the western states in response to jet fuel supply and distribution problems
- 2023 Landslide Oregon coordinated with California to support fuel deliveries to southern Oregon coastal communities affected by Highway 101 closure
- 2023 Annular Solar Eclipse Oregon collaborated with WSPC states in the path of annular eclipse (October 14) to discuss potential fuel sector concerns

Challenges to Regional Coordination



Regional Coordination Can Depend on Circumstances Beyond State Control



Obtaining California waiver for lifting truck weight and axle limits to allow Oregon fuel trucks on California highways require:

- Presidential Declaration
- Federal Approval
- Governor(s) Emergency
 Declaration and Executive Order Demonstrate fuel is necessary to
 prevent loss of life
